Course Description

ETC 514 is the second course in a two-quarter design of math methods courses that examine theoretical perspectives on mathematics education and methods of teaching and learning mathematics at the elementary and middle school levels. Candidates acquire and demonstrate practical experience in the understanding of the mathematics concepts and methods taught in grades K-8. In this second course, candidates investigate various teaching strategies to motivate students, explore what it means to know and do mathematics, to solve problems, to use assessment to inform instruction, and to teach math equitably to all children. Course includes components of state requirements for certification.

Course Outcomes

This course will prepare students to:

- Design engaging learning experiences for students and model with mathematics based on knowledge of student learning, content, community, equity, and curriculum goals
- Implement effective instructional strategies and assessments that support critical thinking and problem-solving skills and promote perseverance in solving problems
- Integrate appropriate technology and use tools strategically in the learning environment
- Develop student capacity to look for and make use of structure, evaluate reasonableness of results, and attend to mathematical precision
- Develop student capacity to reason abstractly and quantitatively, construct viable arguments, and critique the reasoning of others

Shared Agreements

Our primary commitment is to **build relationships** both with each other and within ourselves. Grading Scale

Course Assignments and Grading

Three Lesson Learning Segment (40% of Final Grade)

Based on a central focus (one standard), candidate designs a three lesson-learning segment, using the Teacher Certification Program's instructional plan and unit plan templates. The three lessons demonstrate alignment between the central focus, standard, daily learning targets, learning tasks, and assessments. Candidate uses the CityU lesson plan template to design three connected lessons that build upon one another. Additionally, the content for this learning segment must be found within the Common Core Math standards for grades 4-8.

Craft a Variety of Assessments (20% of Final Grade)

Candidates create a variety of original assessments designed to help students sequentially monitor their progress within the learning segment toward reaching a learning target. Candidates focus on all forms of assessment (pre-assessment, formative, and summative) and include assessments that promote student voice (e.g., using a rubric to self-evaluate).

Learning Segment Presentation and Reflection (20% of Final Grade)

Candidates complete an instructional demonstration during the course. Each candidate selects one component (up to 15 minutes) of the lesson segment and teaches this plan to other candidates. During the presentation, the candidate presents the learning targets (content and academic language), integrate academic language learning experiences, gives step-by-step examples on how to teach the mathematical concepts, promotes equitable math instruction to ALL learners, uses visual models and provides resources to enhance instruction, and instructs specific learning experiences to guide colleagues' participation with the math lesson. After the presentation, candidate writes a one or two page reflection describing the planning and instructing experience for the lesson presentation and analyzes any changes he or she would make to the lesson presentation in the future.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
