COURSE DESCRIPTION

Those who provide care for the elderly people, or are involved in advocacy for the elderly, need knowledge about the physical process of aging. This course explores the physiological changes that accompany the process of aging in the context of social, psychological, and economic factors that influence health status. Discussion topics include issues such as etiology of selected disorders, prevention, health promotion and maintenance, community and public health as well as complementary and alternative systems.

Course activities

Class participation through discussion activities is an integral part of this course. To provide a structure for balanced participation and allow students to maximize the benefit of the discussion activities, it is required to follow these guidelines: 1) Post responses to discussion questions in the first three days of the school week (Monday through Wednesday in online classes; various days in mixed-mode classes). 2) Post at least four or more thoughtful and topic-relevant comments to responses made by classmates over at least three different days of the school week. 3) Respond to any questions that the instructor has regarding students' original post by the end of the school week.

Book review

Student will write seven- to eight-page, double-spaced review of *Another country* by Mary Pipher. In this review, students will evaluate what details from the book bring the subjects to life and what does it teach them about health, care-giving, aging, generational relations, death and resiliency that many elders display in the old age? Additionally, students will discuss how the topics raised in the book relate to the topics in the textbook and class discussions and what they did learn from reading this book. In this review, student are expected to combine their own thoughtful analysis with ideas and information found in other sources. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings. Review must meet APA requirements of format and style. Students must cite the sources of all ideas, facts, and information used that are not their own, even if they have put the information into their own words. Failure to do so is plagiarism, even if the oversight is unintentional.

Application papers

Using the concepts covered in this course, students will write two five- to six page application papers as part of the assignments to meet the learning objectives of this course. In these application papers, students will research a specific disease, disorder or health issue of aging. Topics may include, but are not limited to, the following: 1. Alzheimer's disease; 2. Osteoporosis; 3. Cancer in older age (breast, cervical, prostate, colorectal, etc.); 4. Hearing and vision issues; 5. Heart conditions; 6. Diabetes; 7. Oral health. Students may also chose other themes or topics, but they need to get an approval from the instructor. In their papers, students will present a selected disorder or health issue and discuss the impact of the disorder or health issue on the individual, family, and community/society. Student are expected to combine their own thoughtful analysis with ideas and information found in a minimum of three other sources. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings. It also must meet APA requirements of format and style. Students must cite the sources of all ideas, facts, and information used that are not their own, even if they have put the information into their own words. Failure to do so is plagiarism, even if the oversight is unintentional. *** You are required to have an instructor approval of the selected article. ***
