Course Description

This course allows teacher candidates to analyze and reflect on the collaborative relationships that will be necessary for developing effective programming for special education students in and beyond educational settings. The course will allow candidates to explore the possibilities for collaborative practices with other professionals in the educational setting, inclusion of family members as part of the team, including student voice in decision-making, and working with community agencies/specialists in special education programming. Topics include supervision and collaboration with paraprofessionals and other school support staff, facilitating student-centered planning, and collaboration with family and community stakeholders to increase success of special education students as they transition between grade levels and into adulthood. This course will provide candidates with the knowledge to facilitate collaborative practices in their classroom setting for and with special education students. Course includes components of state requirements for certification.

Course Outcomes

This course prepares candidates to:

- Identify effective methods for collaborating with various stakeholders in special education programming (teachers, school psychologists, specialists, support staff, counselors, community supports, etc.)
- Analyze the process of student-centered planning for special education students in P-12 settings
- Synthesize the core components of the legal post-secondary transition process for special education students (ages 16-21)
- Create a personal leadership philosophy that will guide their facilitation and collaboration with various stakeholders

Course Assignments and Grading

Transition Planning Process (16-21) - 40% of Final Grade

Candidates research the process of student-centered planning as it relates to the process of planning for transition services process for special education students who are 16-21 years old. Candidates synthesize their research and reflect on ways that they can effectively include all stakeholders, with a special focus on inclusion of the student's own voice in the process.

Personal Leadership Philosophy (40% of Final Grade)

Candidates create a brief 1-2 page statement of their personal leadership philosophy and the guiding principles they will use to lead special education teams and/or facilitate collaboration between various stakeholders within the team. They include concrete strategies for making that philosophy and their guiding principles "visible" within their leadership style.

Participation/Engagement/Essential Dispositions (20% of Final Grade)

Candidates engage regularly and actively in class discussions, activities, and affinity groups as a means of building self-awareness and increasing their capacity and stamina for engaging in self-reflection around issues of identity. Candidates will work to meet essential dispositions criteria in their coursework whether online or in person.

Course Policies

Participation

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
