### **Course Description**

In this course, candidates examine the philosophical, historical, political, and sociological foundations of education and the impact of these interrelated dynamics on current instructional decisions and practices. Candidates investigate some aspect of each of these foundations and relate it to professional practice. Candidates analyze educational practice from a variety of perspectives and consider communication with diverse audiences.

## Specifics of Course Assignments

### **Personal and Professional Philosophy Paper**

Based on required readings, identify several philosophies that operate on an issue within a current school or professional learning community. Name each philosophy and how proponents of each define the issue. Analyze how the differences in belief systems affect teaching and learning and the relationships within the school and/or district professional learning community. Include your personal philosophy and how, as the leader, you would approach a resolution to the identified community issue.

## **Historical and Social Context**

Describe and reflect upon legislation that serves to change or improve a current or emerging educational issue at the national, state or local level. Define the historical, political, economic, and social forces affecting the current dialogue that gave rise to the legislation. Identify how this issue developed and where similar dynamics have been seen in our educational history.

## **Instructor Determined Assignment**

The purpose of this course is both in-depth questioning by professional colleagues and the ability to articulate thinking to a variety of audiences. This final examination asks candidates to write several parts of a real or imagined proposal for a project.

# Course Policies

On-time completion and turn-in of assignments is the expectation, so candidates should plan work accordingly. Late work receives an automatic deduction and/or revised due date, determined by the instructor on a case-by-case basis.

## Participation

Whether in class, online, or in a mixed mode setting, students will be graded on their participation in discussions; their ability to present, explain, or defend alternative viewpoints; and the degree to which they have mastered the concepts and principles inherent in the study of educational leadership. Written work will be assessed not only on relevance to the subject presented, but also on adherence to good written form and professional presentation.

## Professional Writing

Follow the APA style guide for written work, unless specified differently by the instructor, including crediting authors, using unbiased language, and details of APA style. Assignments require Standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. Word process and proofread your work. We strongly recommend that you have assignments reviewed by a competent writer for quality of content, clarity of expression, correctness of language convention, and required form prior to submission to the instructor. Exceptions may be made by the instructor.

## End of Course Evaluation (EOCE)
