Course Description

This course is a study of disabilities identified with low-incidence disabilities. Candidates investigate the disabilities identified as Low Incidence: Developmentally Delayed, Autism Spectrum, Moderate/Severe Mental Retardation, Traumatic Brain Injury, Orthopedically Impaired, Deaf/Hard of Hearing and Visually Impaired. Components of the course will include definitions, family involvement, assessments, instructional methods, and procedural and landmark legal issues in Special Education. Candidates will be able to provide appropriate program accommodations for students identified with a low-incidence disability. Course includes components of state requirements for certification.

This course prepares candidates to:

- Interpret information from formal and informal assessments
- Identify components of educational implications of characteristics of various disabilities
- Use verbal and nonverbal language effectively

Grading Scale

Course Assignments and Grading

Communication Board Project (20% of Final Grade)

Candidates develop a communication board consisting of no more than eight (8) pictures for the identified student portfolio provided by the instructor. The candidate presents the communication board to the class. The candidate write a report of no more than two (2) pages to present with the communication board.

Making Action Plans (MAP) (30% of Final Grade)

Candidates will be assigned a student description that reflects a low-incidence disability. Using this description, candidates will develop a Making Action Plans (MAP) for the student in the scenario. This is a two-part assignment with a written report no longer than five (5) pages and a presentation of the report to instructor and/or peers.

Participation/Engagement/Essential Dispositions (20% of Final Grade)

Candidates engage regularly and actively in class discussions, activities, and affinity groups as a means of building self-awareness and increasing their capacity and stamina for engaging in self-reflection around issues of identity. Candidates will work to meet essential dispositions criteria in their coursework whether online or in person.

Course Policies

Participation

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
