Course Description

The Professional and Community Engagement block contains outcomes relating to the professional contribution to the improvement of the school community and profession. Candidates gain an understanding of various culturally sensitive assessment tools to measure academic achievement related to student, family and community engagement. Candidates submit various artifacts which demonstrate their understanding of and the ability to gather data on current engagement practices and utilize this data to support and increase family and community participation.

Course Outcomes

This course will prepare students to:

- Identify access barriers and issues related to P-12 education
- Analyze current school and district engagement surveys
- Develop culturally sensitive assessment tools to measure classroom, school, and community engagement

- Implement tools for gathering data on engagement practices
- Create a classroom/school/community plan to increase engagement
- Analyze and reflect upon responsive teaching techniques

Course Assignments and Grading

Professional and Community Engagement Plan (80% of Final Grade)

Candidates develop an action plan to enhance the engagement of stakeholders in their educational settings in order to ultimately improve student learning and engagement. The action plan should have multiple action items but should have a consistent theme or focus from the following: 1) stakeholder (e.g., student, parent, teacher, etc.), 2) grain size of educational setting (e.g., classroom, school, or broader community), or 3) barrier (e.g., trauma, personal biases, finances, language, cultural disconnect, etc.) with the intent of creating a coherent plan. Action plan items should be directed both toward gaining data and information to develop a rich understanding of engagement barriers for stakeholders as well as toward preventing, reducing, or removing those barriers to the extent possible. Candidates include an analysis of the potential benefits and challenges to implementing the action plan items.

Example action plans:

- A focus on trauma (barrier) in classrooms, schools, and the community (grain size) for students (stakeholder).
- A focus on parent engagement (stakeholder) within the school (grain size) to address language and cultural disconnect (barriers).
- A focus on classroom engagement (grain size) for students and families (stakeholders) to address language (barriers).
- A focus on engagement of teachers (stakeholders) with the district (grain size) to address trauma in children (barrier).

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
