Course Description

The purpose of this course is to provide candidates opportunities to explore models for analyzing and managing student behavior. The course emphasizes basic types of student behavior, motivation, prevention strategies, intervention strategies, and behavior change plans. Practical application of these principles will be demonstrated through the completion of data collection samples, a functional behavioral assessment, positive behavior support plan, and emergency response protocols for use of restraint and/or isolation interventions.

- Develop and design an effective behavioral intervention plan
- Evaluate human behavior in a classroom setting
- Accurately collect and record data related to a student behavior

Course Assignments and Grading

Functional Behavior Assessment (FBA) (30% of Final Grade)

Candidates collect and analyze data through multiple measures in order to determine the function of a student's behavior. The assessment should cover all components of an FBA template provided by the instructor and be written in legal compliance with current WAC and RCW state requirements for the provision of special education services to students with disabilities.

Behavior Intervention Plan (BIP) (30% of Final Grade)

Candidates create an effective Behavior Intervention Plan (BIP) based on their already completed Functional Behavioral Assessment (FBA). In the BIP, candidates identify an

appropriate replacement behavior, develop an intervention, and plan for implementation. The plan should cover all components of a BIP template provided by the instructor and be written in legal compliance with current WAC and RCW state requirements for the provision of special education services to students with disabilities.

Research, Reflection, and Self-Care Action Plan (20% of Final Grade)

For this assignment candidates will research and reflect on the topics of secondary trauma, compassion fatigue, and burnout as they relate to instruction in the K-12 environment. Candidates self-assess their own current state of mind relating to both secondary trauma and their current self-care practices. Based on the data collected from their research and self-assessment, candidates will write a reflective action plan that includes individualized strategies and goals for how they will proactively recognize and combat secondary trauma and/or burnout both for themselves and for their colleagues. Candidates will also create a collection of individualized self-care strategies that they can use during the school year.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
