Course Description

This course is the second in the Behavior Analysis sequence and is for candidates pursuing a special education endorsement. Candidates will apply concepts from Behavior Analysis I in order to make revisions for legal compliance on Functional Behavioral Assessments (FBA) and Behavioral Intervention Plans for special education students exhibiting challenging behaviors. Candidates will also explore the state and federal laws surrounding disciplinary actions for special education students, including Emergency Response Protocols (such as isolation and restraint) in public school settings. Course includes components of state requirements for certification.

Course Outcomes

This course prepares candidates to:

- Understand responsibilities as a special education teacher regarding procedures for Functional Behavioral Assessment, manifestation determination, and behavior intervention planning
- Understand laws, policies/regulations, implications, and ethical considerations regarding discipline, emergency interventions, restraint, and/or isolation being used with special education students
- Evaluate strategies for crisis prevention and de-escalation of aggressive behavior
- Evaluate strategies for increasing acceptance and inclusion of individuals with disabilities
- Analyze pre-written FBAs and BIPs to evaluate for strengths, weaknesses, and suggest improvements.

Grading Scale

Course Assignments and Grading

Emergency Response Protocols (40% of Final Grade)

Candidates examine the current issues nationwide and within WA state related to the use of restraint and isolation/seclusion for students in special education. Candidates identify the implications involved in emergency response protocols and/or physical interventions, with an emphasis on *evaluation and application of positive alternatives* (verbal de-escalation, SEL, positive behavior supports, etc.) to using restraint and/or isolation as behavioral interventions for special education students.

FBA/BIP Analysis and Revisions (40% of Final Grade)

Candidates will critically evaluate a Functional Behavioral Assessment (FBA) and associated Behavior Intervention Plan (BIP). After evaluation and analysis of the documents, the candidate will suggest revisions to increase the quality, consistency, alignment, and/or legal compliance aspects based on their knowledge and skills gained in their previous Behavior Analysis class. Candidates are encouraged to examine existing FBAs and BIPs at their local school. However, if those are not accessible, the instructor will provide examples for candidates who need them.

Participation/Engagement/Essential Dispositions (20% of Final Grade)

Candidates engage regularly and actively in class discussions, activities, and affinity groups as a means of building self-awareness and increasing their capacity and stamina for engaging in self-reflection around issues of identity. Candidates will work to meet essential dispositions criteria in their coursework whether online or in person.

Course Policies

Participation

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode

courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
