COURSE DESCRIPTION

This course introduces various aspects of forensic psychology. It examines problems, limitations, roles, and responsibilities of psychologists and other human services professionals working along with law enforcement forces and the justice system. Other topics covered in this course include: techniques of criminal investigation, risk assessment, trial consultations, interrogation and confessions, sexual abuse and harassment, and discrimination.

Course activities

Class participation through discussion is an integral part of this online course, although it is typically less formal than other work submitted throughout the course. Participation is defined as active engagement in a discussion or other online activity. Quizzes (equally weighted)

Students will take weekly equally weighted online quizzes to reinforce the course materials. The quizzes will test your ability to utilize psychological terminology as well as the identification and application of proper psychological concepts for a given problem. All quizzes are closed book and notes.

Application papers (two equally weighted)

Students will prepare two papers, six- to seven pages long, on specific problems related to the concepts discussed in this class. They may choose which problem is to be written about for each of the four

papers, however, each paper should present an issue from a different category listed below: Techniques of criminal investigation – psychological profiling autopsies, hypnosis, and detecting lies; Violent and aggressive behavior – risk assessment and related recommendations; Child custody and related decisions; Trial consultation (jury selection, preparing witnesses, etc.); Insanity and competency; Discrimination; Sexual abuse and sexual harassment; Death penalty trials and appeals.

In their papers, students should combine their own thoughtful analysis with ideas and information found in a minimum of two sources other than the textbook. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings. This paper must meet APA requirements of format and style. Students must cite the sources of all ideas, facts, and information used that are not their own, even if they have put the information into their own words. Failure to do so is plagiarism, even if the oversight is unintentional.

Synthesis paper

Students are expected to select a high profile criminal or child custody case and write a eight- to ten-page paper describing their role as forensic psychologist working with the defendant and his/her team. In their papers, students should combine their own thoughtful analysis with ideas and information found in a minimum of four sources other than the textbook. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings.
