Course Description

In this course, students develop Korean language skills while learning about Korean culture and technology. Students learn Korean reading and writing skills through vocabulary development and grammar practice and develop aural comprehension and speaking skills through conversations in Korean related to culture and technology. Students apply their understanding of Korean culture and language skills to fundamental concepts of website development, administration, and functions of a web Content Management System (CMS). There are no prerequisites required.

Course Outcomes

By the end of the course, students will be able to:

- Demonstrate Korean language proficiency in structured conversations about topics learned in the course.
- Discuss major elements of Korean culture, including language, norms, rituals and ceremonies, values and beliefs, and artifacts.
- Apply fundamental skills of website design.
- Analyze features of a web content management system.
- Develop a basic website showcasing their Korean language and technology skills.

Grading Scale

The grades earned for the course will be calculated using City University of Seattle's decimal grading system, found in the current University Catalog (<https://www.cityu.edu/catalog/>).

Course Assignments and Grading

The instructor will provide grading rubrics that will provide more detail as to how this assignment will be graded.

The Muddiest Point (MP)

At the start of each module, students are required to submit the Muddiest Point (MP) activity. The MP consists of writing and submitting a brief reflective essay (no more than 50 words)

identifying the most confusing part (i.e., the "muddiest point") of the content covered in the module. If a student understands all concepts, the student needs to explain the most exciting aspect. There is one multiple-choice question from the required readings to demonstrate that the student understood the required readings. The purpose of this activity is to stimulate student engagement. The instructor uses the MP to assess how students understood the required readings and customize the lecture scope to implement Just-in-Time Teaching (JiTT).

Discussion Board (DB)

During each module, students will participate in a discussion activity covering topics of Korean culture and technology. Participation through discussion is an integral part of this course. It is defined as active engagement in a discussion or other activity. Instructors will determine the type of activities and their due dates; moreover, different DB activities will have different substance and length guidelines. The instructor will provide specific instructions to students.

As part of this activity, the instructor will provide prompts related to course topics. Students post an answer to the discussion topic to the online Discussion Board. By the end of the module, students also respond to two other classmate's postings. Although the tone of the postings and responses can be informal, the instructor will expect the content to be on a professional level. Comments and questions for discussion should be clear and thoughtful, with correct grammar, spelling, and punctuation. As with written assignments, the quality of discussion postings and responses will be graded on both content and presentation.

Hands-on Practice (HOP) - Modules 1-10

During each module, students complete online Hands-on Practice (HOP) exercises. The primary focus of the HOP exercises is for students to learn Korean specific language skills in Modules 1-5 and fundamental web design skills in Modules 6-10. In all modules, students are also learning about elements of Korean culture. Although accuracy is important, this activity is for students to learn and practice skills using the provided guidance and direction. Therefore, students will be graded based on their engagement in the practice exercises.

Language Exercise (LE) - Modules 1-5

During modules 1-5, students complete a Language Exercise that supports the Korean language skills taught in the course and reinforces Korean cultural competence. In this activity, students apply the knowledge and skills from the HOP to complete a verbal or written assignment demonstrating their developing Korean language skills. This assignment is graded on accuracy.

Web Design Exercise (WDE) - Modules 6-10

During Modules 6-10, students create and update their own website and demonstrate website development and content management skills. In this activity, students apply the knowledge and skills from the HOP to develop a website demonstrating their understanding of Korean culture, language, and technology skills using a provided website template.

Knowledge Check (KC)

Weekly quizzes measure knowledge concepts acquired including Korean culture, vocabulary, and reading comprehension in a foreign language, and review of basic web development concepts including tools and tool functions.
