Course Description

US History through Native Perspectives covers the span of indigenous history in North America from since time immemorial through present day. The course will approach United States History from an indigenous perspective and reincorporate voices and experiences typically omitted from traditional US History courses. Students will work with deep and heavy themes, including identity, sovereignty, activism, education, and community. These themes undercut the way history is told and form essential pieces of our understanding of the way the world works. Engaging with these themes through activities including guest speakers and cultural learning experiences will require students to think critically and to take on controversial topics with maturity and respect. This course furthers the goal of decolonizing educational experiences.

Course Outcomes

This course will prepare students to:

- Understand the indigenous history of the United States, including the historical and present-day relationship between Native tribes and the United States.
- Critically analyze primary, secondary, and tertiary historical sources
- Conduct inquiry-based research projects
- Prepare critical arguments based on evidence, research, and analysis

Course Assignments and Grading

Myth-Busting Argument (23% of Final Grade)

Students will present (written or oral) a well-researched, evidence-based argument debunking a common misconception about pre-contact Native North American civilizations. Myths include but are not limited to population size, government structure, technology levels, and social make-up. Students will use evidence from reading and research to show why myths are incorrect and how debunking them can change perceptions about Native people and Native history.

First Contact Textbook Rewrite (23% of Final Grade)

Students will conduct an analysis (written or oral) of high school textbook portrayals of first contacts between Indigenous peoples and European explorers, comparing these accounts with Native histories of these encounters. Students will analyze textbooks for erasure, misrepresentation, and perpetuation of myths about Native people and Native cultures. Using supplemental research and texts, students will correct the textbook portrayals of these first encounters by "rewriting" problematic sections of common textbooks used in secondary schools.

Settler Colonialism Document Analysis (23% of Final Grade)

Students will conduct an analysis (written or oral) of a founding document of the United States (Declaration of Independence, Constitution, foundational Supreme Court cases, etc.) and identify the way the document incorporates and perpetuates the settler-colonial ideology of American history. Students will use historical knowledge of the Doctrine of Discovery, the Marshall Trilogy, the Haudenosaunee influence on the US Constitution, and other background knowledge to inform their analysis. Their analyses will show how these documents and the settler-colonial ideologies contained within them continue to shape American society and policy in the modern day.

Instructor Determined Assignments (31% of Final Grade)

The instructor will determine a set of activities that support the course outcomes and major assignments of the class. These activities could include collaboration, discussion, participation, peer-review, learning reflections, learning checks or other activities online or in-class. Descriptions are provided by the instructor in the course.
