Students present a portfolio of cumulative learning as well as their personal and professional growth. This presentation, in front of a panel of instructors and colleagues, is a celebration of the student's progress throughout the program. They will also present their research or capstone project results.

### **Portfolio Presentation (100% of Final Grade)**

*Students will prepare a 6-slide summary* that shows significant learning that helped to shape their sense of self as educator, and personal/professional objectives in the program.

- Approach to school counselling What is it that you value more about yourself and your work? How does it inform your work with students? Where does it come from (culture, family, lived experience, etc). How does it play a role in your approach to school counselling and approach to education?
- 2. Strengths and growth Since your experience in the program over these two years, what strengths have you noticed about yourself? How have you grown? How will you build on this in the future?
- 3. Theory, Knowledge, Skills What theory, knowledge, and skills developed in this program inform your worldview? Explain how/why they resonate with you.
- 4. Capstone

Often, a capstone topic is personally meaningful to the researcher in some way. What brought you to this topic? How is it meaningful to you?

- 5. Work in your school/community Why do you want to do this work? How will your work (and your approach to it) contribute to your school/community?
- 6. Personal Philosophy of Counselling statement Having reflected on these questions and your coursework, describe what guides your work with students. How would you articulate your personal philosophy of counselling statement?
