COURSE DESCRIPTION

In AC 502, Applied Management Accounting Concepts II, emphasis is placed on financial statement analysis, corporate finance, decision analysis, risk management, investment decisions, and professional ethics. Students will analyze information, evaluate options, make recommendations, and provide information useful to support management decision-making. AC 501 and AC 502 concentrate on topics routinely tested on the CMA and CGMA certification examinations and will help students prepare to sit for these exams.

Homework

Completing all assigned homework will help ensure that students successfully master the concepts in this course. The best way for students to gain a thorough understanding of the underlying concepts is to apply those concepts to solve problems. Several topics will be covered each week. The assigned homework for each week will consist of completing knowledge check questions plus a mini-quiz consisting of several multiple-choice questions for each topic covered during that week. Homework will be completed online using the Wiley course software.
