## **Course Description**

In this course, candidates examine the basic principles of culturally sustaining instructional design and delivery as applied to the K-8 curriculum. In the pursuit of understanding foundational elements of instructional design and practices, candidates experience a student-driven approach to learning that allows for each person to be their authentic selves, reflect, problem-solve, be creative, and offer feedback. Candidates are introduced to community-driven, experiential, and multidisciplinary teaching and learning that will support the critical inclusion of the cultural wealth of all students and families. This course includes components of state requirements for certification.

## **Course Outcomes**

This course will prepare students to:

- Understand inclusive practices in selecting, using, and adapting curricula, technology, and resources that effectively align with learning goals, processes, and intentions in developmentally appropriate, culturally sustaining, and antiracist ways
- Align learning targets, goals, and intentions with regional and national requirements, curriculum frameworks, and district, school, and classroom goals
- Align feedback and assessment strategies with learning targets, goals, and intentions
- Design student-driven instructional activities that allow each student to be their authentic selves, reflect, problem-solve, be creative, and offer feedback
- Create scaffolded learning opportunities that are suitable for all students especially multilingual students, advanced students, and students who need accommodations
- Design a variety of methods of establishing two-way connections between families and teacher

## **Shared Agreements**

Our primary commitment is to **build relationships** both with each other and within ourselves. ## **Course Assignments and Grading**

#### **Lesson Plan (30% of Final Grade)**

Candidates will create a content-specific lesson plan (or unit) aligned with adopted state standards. The lesson plan (or unit) will include student-driven, experiential, and culturally sustaining instructional methods and techniques, a variety of aligned feedback protocols and assessments, scaffolding techniques for all learners especially multilingual students, advanced students, and students requiring accommodations, a logical sequence of activities designed to advance conceptual understanding, opportunities for reflection, and a rationale for the learning tasks.

#### Unit Plan (30% of Final Grade)

Candidates will create a content-specific unit plan aligned with adopted state standards. The unit plan will include student-driven, experiential, and culturally sustaining instructional methods and techniques, essential questions, a variety of aligned feedback protocols and assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks.

### **Project Design (20% of Final Grade)**

Candidates will move through elements of project design in their effort to answer a driving question they created in pursuit of understanding culturally sustaining instructional design and delivery. The final project design will incorporate artifacts from their learning and experience in the course.

## Participation, Reflection, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all coursework, including required assignments, class discussions, reflections, and activities. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

## **Course Policies**

#### **Participation**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
