Course Description

This course examines the basic principles of instructional design and delivery as applied to the K-8 curriculum. The course emphasizes student centered instructional design including assessment of the student learning context, best practices, essential learnings, common core standards, and differentiation. The course introduces candidates to elements of effective planning and instruction including positive inclusion of cultural and community assets of students and families. This course includes introduction to state requirements for certification.

This course will prepare students to:

- Understand best instructional and assessment practices in selecting, using, and adapting curricula, technology, and instructional and assessment resources that effectively align with learning goals, are developmentally appropriate, and culturally responsive and free of bias
- Identify and communicate learning targets suitable for ALL students that align with regional and national requirements, curriculum frameworks, and district, school, and classroom goals
- Align assessment strategies with learning targets
- Design a variety of methods of establishing two-way connections between families and teacher

Lesson Plan (40% of Final Grade)

Candidates will create a content-specific lesson plan (or unit) aligned with adopted state standards. The lesson plan (or unit) will include: student-centered instructional methods and techniques, a variety of aligned assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks.

Unit Plan (40% of Final Grade)

Candidates will create a content-specific lesson plan (or unit) aligned with adopted state standards. The lesson plan (or unit) will include: student-centered instructional methods and

techniques, a variety of aligned assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
