COURSE DESCRIPTION

This course is the application of literacy instructional skills with P-12 students. Topics include materials selection, diagnosis, planning, assessment, analysis interpretation, and evaluation of literary and expository texts. Upon completion of this course, candidates can effectively assess, diagnose, and plan appropriate intervention for students struggling in reading.

Literacy Resource Guide and Calendar

Candidates develop a monthly literacy instruction calendar for the school year. This calendar schedules reading comprehension strategy instruction. Accompanying the calendar is a personal resource guide candidates create. The resource guide includes a glossary of literary terminology, list of literature titles which contain grade level appropriate examples of literary elements for students, and a list of titles appropriate for comprehension strategy instruction. The literature included provides opportunities for teacher modeling of comprehension strategies using read aloud and/or think aloud. The resources include literature which addresses understanding and respect for cultural, linguistic, and ethnic diversity

Response to Intervention Assignment

Candidates assess a struggling student using an appropriate assessment instrument for Tier III in the Washington State K-12 Reading Model, identify the reading deficits, develop a diagnosis using the Sequence for Diagnosing Reading Difficulties K-12 reading model and an intervention plan. Candidates implement the plan, assess learning, and assist student to set personal literacy learning goals, and complete a reflective analysis on the experience.

Candidates develop and teach two comprehension strategy lessons utilizing literature selections from their Literacy Resource Guide and Calendar and complete a reflective analysis on the experience.

Instructor Determined Assignments; including participation

Class participation expands the participant's knowledge and ability to implement strategies learned in the course.
