# **COURSE DESCRIPTION**

This course focuses on framing and defining the analytics problem or challenge. Students will clearly define the scope, resources, and stakeholders of the analytics problem. They will also learn how to identify research questions, analytics hypotheses and potential sources of data. At the end of this course, students will have a full understanding of the steps that must be successfully completed for any analytics problem prior to gathering data.

## SPECIFICS OF COURSE ASSIGNMENTS

#### Instructor Determined Assignments and Activities

Whether in class, online, or in a mixed mode setting, students will be graded on their participation in class discussions; ability to present, explain, or defend alternative viewpoints; and the degree to which they have mastered the concepts and principles inherent in the study of business management. Online and Hybrid classes are required to use online discussion board (Blackboard - Bb). Participation through discussion is an integral part of this course, including engagement in discussions with enhancing points, new ideas, constructive disagreement, real-world examples, personal insight, expanded resource material, and collaborative sharing. Written work will be assessed not only on relevance to the subject presented, but also on adherence to good written form, APA style, and professional presentation. The instructor may also choose to create additional activities to support learning in the classroom or online.

#### Weekly Exercises

Throughout the course, students will be presented with different scenarios involving business problem formulation. The exercises will focus on the principles of business problem framing. Students will formulate a business problem, create a stakeholder list and power/interest matrix, delineate constraints and refine their business statement, and formulate a business case. Adherence to APA formatting is required. These exercises will help students develop the skills needed to formulate the components of the final case analysis which include Introduction, Background, Alternatives, Proposed Solution, and Recommendation.

#### Final Project

Throughout the course, students will be presented with different scenarios involving enterprise use of business and analytics problems. The instructor will assign a case or provide guidelines to use in selecting a case for analysis. If students select the case, they will need to submit it to the instructor for approval. The case analysis will focus on formulation of business statements and analytics problems, and students will synthesize their findings throughout the course into a complete business case and provide recommendations. Adherence to APA formatting is required and the case response should be 5000-7000 words in length (excluding cover page and reference page) and include a minimum of three (3) references. The components of this case analysis include Introduction, Background, Alternatives, Proposed Solution, and Recommendation.
