COURSE DESCRIPTION

This course will evaluate the origins of laws and definitions of juvenile delinquency, the techniques used to measure delinquency, sociological theories of crime, and institutions of social control for juveniles, including the juvenile justice system and delinquency prevention programs.

COURSE OUTCOMES

In this course, learners:

- Evaluate the effectiveness of the juvenile justice system.
- Evaluate the relationship between environmental factors (such as family, peers, school, and drugs) and delinquent behavior
- Evaluate the methods used by sociologists to measure crime and delinquency
- Examine the origins of juvenile delinquency
- Assess the relationship between a number of demographic variables (i.e., sex, race, class) and delinquency
- Assess the ability of sociological theories to explain crime and delinquency

SPECIFICS OF COURSE ASSIGNMENTS

Course activities

Class participation through discussion is an integral part of this online course, although it is typically less formal than other work submitted throughout the course. Participation is defined as active engagement in a discussion or other online activity. To provide a structure for balanced participation and allow you to maximize the benefit of the discussion boards, it is recommended that you follow these guidelines: 1) Post your responses to discussion questions in the first three days of the school week (Monday through Wednesday). 2) Post three or more thoughtful and topic-relevant comments to responses made by classmates during the last four days of the school week (Thursday through Sunday). 3) Respond to any questions that your instructor or peers have regarding your original post by the end of the school week.

Quizzes (equally weighted)

Students will take weekly equally weighted online quizzes to reinforce the course materials. The quizzes will test your ability to utilize psychological terminology as well as the identification and application of proper psychological concepts for a given problem. All quizzes are closed book and notes.

Application papers (two equally weighted)

Students will prepare two papers, six- to seven pages long, on specific problems related to the concepts discussed in this class. They may choose which problem is to be written about for each of the four papers,

however, each paper should present an issue from a different category listed below: 1. Gender and delinquency; Family and delinquency; Peers and delinquency; Schools and delinquency; Drug use and delinquency; Delinquency prevention; Delinquency and juvenile justice abroad; Juvenile justice system at work.

In their papers, students should combine their own thoughtful analysis with ideas and information found in a minimum of two sources other than the textbook. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings. This paper must meet APA requirements of format and style. Students must cite the sources of all ideas, facts, and information used that are not their own, even if they have put the information into their own words. Failure to do so is plagiarism, even if the oversight is unintentional.

Synthesis paper

Students are expected to select a high profile juvenile criminal case and write an eight- to ten-page paper analyzing it from the social and psychological perspective as well as outlining the most effective, hypothetical treatment plan for juvenile offender involved in this case. In their papers, students should combine their own thoughtful analysis with ideas and information found in a minimum of four sources other than the textbook. Therefore, as in any scholarly writing, students should not merely copy information from another author, but use evidence to support the contentions they have drawn from their findings and critically analyze related literature - this paper has to be an analytical paper, not a summary of readings. This paper must meet APA requirements of format and style. Students must cite the sources of all ideas, facts, and information used that are not their own, even if they have put the information into their own words.
