Course Description

An introductory look at the world's political, economic, and social structures in order to gain a better understanding of how nations interact and why world leaders take particular actions to further the interest of their nations. Emphasis is placed on the impact which world events have on individuals and the lives that they live.

- Summarize economic and political issues involving world trade and potential impacts to individual, organizational, and community behavior
- Discuss how world history affects modern diplomacy

Course Assignments and Grading

Weekly Quizzes (20% of Final Grade)

Students will demonstrate an understanding of course concepts through engaging with and practicing content by doing weekly quizzes. Each weekly quiz requires a passing score of 75% in order to move forward in the course. Weekly quizzes can be taken an unlimited number of times to achieve a passing 75% or higher score. To prepare for these quizzes, students will complete self-assessments through daily knowledge checks and hands-on course activities (including but not limited to taking notes, making source annotations, completing case studies, creating short webcam videos, and filling out worksheets and charts). The feedback given by the instructor for these activities will support achievement of the required quiz scores as well as the weekly Create assignments.

Reflections (20% of Final Grade)

Students will answer weekly writing prompts that support their reflection on course concepts learned during the week. Each response will be at least 300 words and address each of the prompts thoroughly.

Create Assignments (50% of Final Grade)

Week 1: Research Topic Proposal – International Cooperation or Conflict Paper

For the final paper students must analyze and evaluate an example of international cooperation **OR** an event of international conflict. The final paper must cover the following key elements: **1)** brief history of the topic and major actors, **2a)** What is the main objective of cooperation and how do the actors seek to accomplish their goals? Or **2b)** What are some of the reasons that the tensions escalated (Political, religious, cultural, economic, etc.), **3)** What is your position on the topic? Do you agree or disagree with the decisions of the major actors? **4a)** What are any recommendations you can think of to improve on what the actors have built so far? Or **4b)** what are any recommendations you can think of that might have helped to avoid the conflict?

Choosing a topic and analyzing its potential for further review is the preliminary assignment that will help students complete their final papers. Therefore, the proposal should express which topic the student will research and evaluate, either an international conflict or cooperation. The proposal should be 150-200 words and must include a brief description of the event, and a research question.

- The International Space Station (ISS)

- The Middle Eastern Cold war (Iran and Saudi Arabia)
- China and Taiwan relations
- The Breakup of Yugoslavia
- The Belgian Congo and Independence
- The Space Race between USSR and USA
- Russia and the Invasion of Crimea

Week 2: Research Reference List for the International Cooperation or Conflict Paper

Students use the City University of Seattle library to find and annotate at least six articles related to their topic in international cooperation or conflict and the main concepts that they have chosen to analyze for the final paper. Sources chosen should also provide evidence for analysis of the main concepts. All course materials listed must be scholarly, peer reviewed, current, and relevant to the topic. Students will complete a reference page of six chosen articles from sources that follows APA 7th edition conventions for formatting.

Week 3: Literature Synthesis and Outline for the International Cooperation or Conflict Paper

Students use the six source articles from Create Assignment Week 2's Reference List to write a 250-300 word, one-page summary of their synthesis findings. In this synthesis, students should identify the main claims presented in the source articles and describe why this information is relevant to their topic. From this synthesis, students will also create an arguable claim, and a four main point outline.

Week 4: The International Cooperation or Conflict Paper Complete Rough Draft

Students will use their research, synthesis and working thesis to write a complete academic draft of their research paper. The draft is expected to be rough but with all sections completed. This draft should be 4-5 body pages, which includes an introduction and a clear working thesis, body paragraphs, and a conclusion. The body paragraphs should include a discussion of how the topic relates to the course concepts learned in class. Students must demonstrate an understanding of how their research is connected to the course outcomes, however the draft does not need to be a seamless integration of course concepts and topic. Additional pages include a title page and a references page, and the paper's citations and formatting must demonstrate adherence to APA conventions.

Week 5: The International Cooperation or Conflict Paper Final Draft

Students will revise their rough draft into a 4-5-page final draft that has improved coherence, analysis, organization, mechanics, and APA format. The final draft should include a highly cohesive integration of course concepts, analysis of the topic, and synthesis of additional sources, as well as adhere to APA 7th edition conventions for citations and formatting.

Final Exam (10% of Final Grade)

Students will demonstrate an understanding of course concepts through 23 multiple choice, fill-in-the-blank, true/false, multiple answer, and matching questions and 2 short essay questions on a final exam. All questions, except for the short essay questions, come from the course weekly quizzes.

Course Policies

Late Assignments

Late assignments are accepted. Students can submit or resubmit any assignments up until the last day of class. In all Flex Courses, late assignments are accepted through the last day of the course, which is Sunday at midnight at the end of Week 5. A late assignment is one that is submitted after the due date and time or after any extension has expired. No late submission is accepted beyond 48 hours past the final day of the course, without instructor approval. Coursework received after one week (seven days) will not be graded and will receive a zero grade.

There are suggested due dates in the Course Map that students are highly advised to adhere to as this allows them to keep on track and enables them to complete everything with the best retention of information and educational experience. However, students can submit assignments as early as they wish or as late as the last day of class.

Final Assignment Due Date

According to policy, final assignments for each class at CityU must be due on or before the final date of the course as indicated in the university's course information system. Due dates that extend beyond the final date of the course may negatively impact tuition funding for students. Note that in Flex Courses, students are encouraged to submit all assignments by the suggested due date listed in the Course Map and to adhere to the final day of the course as the deadline for any assignments including the final assignment.

Practice Assignments

Each lesson contains a practice assignment. These assignments are not graded but will be evaluated for accuracy. Practice assignments have two purposes: students may demonstrate their understanding of course concepts and develop micro-skills required for graded assignments including Creates, Reflections, Weekly Quizzes and the Final Exam. Targeted feedback on Practice assignments will be given by the instructor that is vital for success in the

course. Completing Practice Assignments is highly encouraged, as Practice assignments often contain tasks that are part of a larger, graded Create or Reflection assignment.

Participation

Students are expected to participate in the course each week in one of the following ways: submission of graded and Practice assignments, taking Knowledge Check and Weekly Quizzes, communicating with the instructor via email, office hours, or phone call to discuss course material or ask for assistance in an assignment. Failure to do these tasks each week will result in being marked absent (see attendance policy below).
