Course Description

This course examines the basic principles of instructional design and delivery. The course emphasizes student centered instructional design including assessment of the student learning context, best practices, essential learnings, common core standards, and differentiation. The course introduces candidates to elements of effective planning and instruction including positive inclusion of culturally-responsive teaching practices

This course will prepare students to:

- Write student-friendly, measurable learning targets that are aligned with standards
- Explain the backwards design process
- Select or create a variety of assessments that align with learning targets
- Plan for an intentional sequence of learning activities and strategies to promote student engagement, motivation, and learning
- Analyze the rationale for various teaching strategies
- Anticipate student misconceptions, alternative conceptions, and developmental errors
- Differentiate for different student learning needs

- Apply culturally-responsive teaching strategies to build community and student engagement

variety of aligned assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks.

Unit Plan (40% of Final Grade)

Candidates will create a content-specific unit plan aligned with adopted state standards. The lesson plan (or unit) will include: student-centered instructional methods and techniques, a variety of aligned assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
