

# **ETC 612: Literacy I: Instruction and Assessment**

## Course Description

This course is an introduction to the knowledge and application of the five essential components of reading: phonemic awareness, phonics, fluency, vocabulary, and comprehension as identified by the National Reading Panel (2000). Candidates will demonstrate understanding of the five components of reading using evidence-based research and then apply that foundational knowledge to the design of instructional activities that meet the needs of diverse learners. In addition, candidates will also develop an understanding of the Science of Reading and how the evidence-based research should inform instruction while designing an explicit structured literacy lesson plan. Finally, candidates investigate theories of second language learning, evaluate language acquisition theories, and review the major factors that affect second language learning.

## Course Outcomes

This course will prepare students to:

- Demonstrate knowledge of the five essential components of reading: phonics, phonemic awareness, fluency, vocabulary, comprehension

- Demonstrate how the results of evidence-based literacy research (the Science of Reading) informs and impacts reading instruction
- Apply knowledge of the five essential components of reading in the instructional design of literacy-based activities
- Design, implement, and assess an explicit, structured literacy lesson
- Demonstrate an understanding of how multilingual students acquire a second language
- Summarize and evaluate potential factors that affect language acquisition and language learning
- Summarize and evaluate social and academic language

# **Course Assignments and Grading**

## **Literacy Foundations Mini-Research Essay and Activity Bank (30% of Final Grade)**

Candidates research the five components of reading (phonemic awareness, phonics, fluency, vocabulary, and comprehension) and write an evidence-based summary of each through a Science of Reading lens. Candidates then analyze how each of the five components are related to Scarborough's Reading Rope (2001) and discuss the reciprocal nature of the strands within The Rope and how they contribute to skilled reading. Research essay should be 1-2 pages double spaced per reading component for a total of 5-10 pages.

Based on the foundational information discovered, candidate will develop a bank of activities that includes one activity for each of the five components. Each activity should be based on a grade level Common Core State Standard, with a clear description/plan for implementation, rationale, support/scaffolding (differentiation), and plan for informal or formal assessment. Candidates must review five or more professional and/or scholarly articles to support their research and activities.

## **Language Acquisition and Learning (25% of Final Grade)**

In this assignment candidates gain an understanding of how all children acquire and learn language. Candidates research factors that affect language acquisition and language learning for students who are multilingual learners and share those findings in a medium of presentation approved by the course facilitator. Research and presentation must include:

1. Review of the WIDA Standards and examination into how they can be applied in the classroom in support of multilingual learners;
2. Identification of the individual and socio-cultural factors that may influence the learning of multilingual learners as they acquire and learn a second language;
3. Evaluation of factors that affect language acquisition and language learning for multilingual learners;
4. Summary of Social Language and Academic Language;
5. Evaluation of how social and academic language in the classroom setting supports language acquisition;
6. Description and explanation of each domain as it relates to the stages of language acquisition for multilingual learners; and
7. Reference list in APA format.

### **Structured Literacy Lesson Plan (25% of Final Grade)**

Candidates design a structured literacy lesson plan based on one of the five components of reading (phonemic awareness, phonics, fluency, vocabulary, or comprehension). The lesson plan must follow the elements of explicit instruction and demonstrate a gradual release of responsibility. The lesson plan will include: a literacy-based Common Core State Standard (CCSS) aligned to the learning target, sequential and explicit direct instruction, guided and independent practice opportunities, a variety of aligned assessments, and a rationale for instructional decisions.

### **Participation, Engagement, and Essential Dispositions (20% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

## **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
