## Course Description

The purpose of this course is to inform candidates of both inclusion and specialist paradigms, including definitions of disabilities and program delivery. This course emphasizes identification, specific needs of students, service delivery, and legal issues. Practical application of these principles forms the foundation for future special education courses.

## Grading Scale

# **Course Assignments and Grading**

## **Matrix of Disabilities (25% of Final Grade)**

Candidates create a matrix that includes definitions related to special needs students. The matrix should organize definitions according to characteristics, cause, prevalence, and strategies to support students in content areas. The final product should be comprehensive, as well as functional for use in future courses and internships.

## **Research on Exceptionality (40% of Final Grade)**

Based upon the completed matrix, candidates select one of the exceptionalities to further research. Candidates explore a medical breakthrough, innovative teaching strategy, assessment method, or other area of current research associated with the chosen exceptionality. The candidates share information in a 3-5 page research paper with the instructor and in a presentation to the class.

## **INCLUDE-method Scenarios (20% of Final Grade)**

Given a scenario by the instructor, candidates discuss and describe student strengths and needs in order to develop accommodations. Candidates use the INCLUDE strategy to develop the accommodation plan for the student with special needs.

## **Participation, Engagement, and Essential Dispositions (15% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

## **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed

mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
