Course Description

In this course, students examine the application of health policy and economic principles in regard to managerial decision making. Students learn about the process for policy development and implementation, key stakeholders and interest groups involved in the health policy process, and how health policy changes over time within the United States. Students assess and discuss key policy initiatives related to cost, quality, and access.

Course Outcomes

This course will prepare students to:

- Analyze the application of healthcare policy and economic principles in regard to managerial decision making.
- Assess and explain key healthcare policy initiatives related to cost, quality, and access.
- Differentiate the roles and responsibilities of key stakeholders and interest groups involved in the healthcare policy process.
- Examine how healthcare policy changes over time within the United States.

- Explain the process for healthcare policy development and implementation.

Grading Scale

Course Assignments and Grading

Assignments

Medical Spending Comparison Paper (30% of Final grade)

Students will write a paper that compares the amount the United States spends on healthcare, compared to any foreign country. In this paper, students will analyze how spending is allocated in each of the two countries, including, but not limited to, end of life care, prenatal care, preventive care, and medications. Students will also include an analysis of the quality of and access to healthcare in the two countries. This 8-10 page paper must be APA formatted and contain a minimum of 8 professional references.

Stakeholders in the Healthcare Policy Process (25% of Final grade)

Students will examine and compare the roles and responsibilities of key stakeholders and interest groups involved in the healthcare policy process. These stakeholders should include, but are not limited to, hospitals, physicians, pharmaceutical manufacturers, insurance companies, and healthcare consumers. This 8-10 page paper must be in APA format and contain a minimum of 8 professional references.

Healthcare Policy Development Paper (25% of Final grade)

Students will examine how healthcare policy changes have occurred in the U.S. from the 1960s to present day. This paper should include, but not be limited to, the creation of Medicare and Medicaid, healthcare reform, and the Patient Protection and Affordable Care Act. This 8-10 page paper must be in APA format, with a minimum of 8-10 professional references.

Essays and Quizzes (20% of Final Grade)

Each week students will write a short (3-5 paragraph) essay on the topic provided in the classroom. Students will have a one-question quiz each week. The quiz is not timed and students may use their text or other materials to research the answer.

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.
