This course examines literacy instructional strategies for English language learners. Topics include reading assessment, vocabulary, and comprehension. Upon completion of this course, candidates have the skills to design and modify reading instruction for P-12 ELL students.

Instructional Plan, Research Report, and Reflection Log

Candidates create and implement an instructional plan for a specific group of P-12 students. The candidates research articles published within the last five years that discuss teaching ELL reading skills at the level of the selected group of P-12 students. The candidates record the process of researching, creating and implementing the instructional plan in a reflection log that includes findings, conclusions with student voice evidence.

Proposal for Positive Impact on Student Learning

Each candidate will present a project proposal for implementation that identifies how selected strategies including core concepts and skills will positively impact student learning in a specific K-12 student context. The proposal includes a process for gathering assessment data, methodology, and analysis.

Instructor Determined Assignments; including participation

Class participation expands the participant’s knowledge and ability to implement strategies learned in the course.
