Course Description

The purpose of this course is to provide candidates with the pedagogical foundations, strategies, and understanding to modify curriculum and make accommodations to the learning environment. This course emphasizes the identification of students' needs, appropriate response strategies, and collaboration between appropriate staff members. Upon successful completion of this course, candidates modify curriculum and make accommodations for students with special needs.

- Apply collaboration skills that build effective relationships between specialists and regular education teachers
- Analyze evaluation results to understand student needs
- Create a lesson plan that meets the needs of all children in the classroom

Course Assignments and Grading

Lesson Plan (40% of Final Grade)

Candidates will create a content-specific lesson plan (or unit) aligned with adopted state standards. The lesson plan (or unit) will include: student-centered instructional methods and techniques, a variety of aligned assessments, a logical sequence of activities designed to advance conceptual understanding, and a rationale for the learning tasks. The lesson plan should be written for general education, with accommodations and modifications for special education students.

Implementation of Accommodations and Modifications (40% of Final Grade)

Develop a concrete understanding of accommodations and modifications for special needs students identified the current list of disabilities qualifying a student for Special Education Services, by: A. Identify the accommodations and modifications of disability identified students by OSPI B. Analyze each accommodation and modification based on the compliance with WACs as it relates to instruction in the general classroom of students with disabilities. C. Implement accommodations to instruction within a classroom setting, D. Collect and assess student data relating to selected accommodations and modifications to instruction in the general classroom of students with disabilities. E. Reflect the effectiveness in selected accommodations and modifications to instruction in the general classroom of students with disabilities.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed

mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
