## Course Description

Participants emerge from this course with an implementation plan to empower student voice and evidence of learning in their K-12 settings as indicated in their National Boards portfolio entries. Candidates will develop strong unit plans containing specific goals to use for student assessment. Candidates will participate in answering questions with a variety of people from diverse content areas pursuing National Board Certification. Through feedback provided in this cohort, the candidate is expected to improve their writing to reflect the three styles: descriptive, analytical, and reflective.

This course will prepare students to:

- Evaluate and apply the results of scientifically based research to inform and improve student learning.
- Articulate the importance of keeping current in knowledge of the field of education.

- Demonstrate that ALL students are engaged in the learning process.
- Evaluate progression of student learning to inform teaching practices.
- Reflect on effective teaching practices.
- Demonstrate knowledge of qualitative and quantitative research, the history of teaching and best practices found within education and instruction.

## Grading Scale

The grades earned for the course will be calculated using City University of Seattle's decimal grading system, found in the current University Catalog (<https://www.cityu.edu/catalog/>).

Grading rubrics with details on how each assignment will be graded are located under *Assignments* and/or in *My Grades* in the online course menu. Students should review the rubric for each assignment prior to completing their work in order to understand how it will be assessed.

## Course Assignments and Grading

### Component 1 (20% of grade)

Candidates will complete a review of all released extended response (essay) questions and submit an essay stating which part of the prompt stood out as challenging and which was familiar. They will connect the prompts to the various National Board standards and determine a process for studying the different sets of questions through identified resources. Candidates will practice a series of multiple choice response questions reflecting on their review process and self-evaluate their readiness for their content.

### **Component 2 (20% of grade)**

Candidates will analyze student work to identify strengths, areas of improvement needed and provide feedback to facilitate learning. They will submit student work samples along with a constructive feedback form to identify next steps of learning for each of the 1-2 students (depends on content of focus area) including lessons to build area of improvement success criteria. Candidates will submit a full final draft of the component including the forms, written response questions on essay, receive peer and instructor review, and self-reflect on what is needed for completion of the component.

### **Component 3 (20% of grade)**

Candidates will video tape 2+lessons to review with peers. They will transcribe the lessons, highlight and compare student and teacher engagement within the video lesson, and respond to National Board written response questions, Component specific, for a full analysis of the lesson for peer and instructor review. This term, two video final submissions are required including questions for peer/instructor review.

### **Component 4 (20% of grade)**

Candidates will identify which assessment formats connect to student needs and PLC work. Candidates connect how the assessments are used, rationale for assessments, connection to PLC, and knowledge of student work for peer, instructor and self-review. Candidates will review and complete the reflection section of the component and analyze successes and areas for future growth. Candidates will submit final drafts of this component along with forms needed.

### **Participation, Engagement, and Essential Dispositions (20% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

## **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
