Course Description

The purpose of this course is for the teacher candidate to understand the collaborative relationships with other educators in the educational setting, inclusion of family members as part of the team, and working with schools/agencies for successful transitions. Topics include techniques to supervise paraprofessionals, transitions, meeting diversity and multicultural needs. Candidates will be able to facilitate meetings involving all appropriate participants and develop successful transition plans.

- Structure appropriate transition placements based on students' cultural and linguistic, social, family and disability needs
- Select and use appropriate teaming and collaboration strategies to facilitate the IEP process and placement meetings
- Identify effective methods for involving paraprofessionals in the classroom

Course Assignments and Grading

Process IEP/Placement Meeting and Written Description (50% of Final Grade)

Candidates collect information on descriptions of teaming, collaboration, and transition practices; description of the roles of the team members; program placement decisions based on the IEP process; identification of accommodations for individuals with cultural differences; and procedures used to provide accessible consultation opportunities with regular education staff.

Transitions (30% of Final Grade)

Candidates identify and summarize the process for the development of Transition Plans for the three major transitions: Preschool to Elementary, Elementary to Secondary and Secondary to adult.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
