Course Description

This course provides teacher candidates the opportunity to build foundational knowledge about human development and developmental theories contextualized within a multicultural and racialized society. Candidates will explore introductory concepts of major theories of identity development and their sociopolitical and historical contexts as they relate to education. Candidates will spend time examining the various parts of their own personal and professional identities, examining implicit bias and personal experiences that have shaped their worldview, and exploration of their own positionality, power, privilege, and intersectional identities within a multicultural society. Candidates will be asked to examine the various ways in which their positionality and intersectional identities may impact their presence with children and families in the K-12 classroom and their teaching pedagogy. Course includes components of state requirements for certification.

Course Resources

Course Outcomes

This course prepares students to:

- Describe the major theories of human identity development across the lifespan and their sociopolitical and historical contexts as they relate to education
- Analyze the ways in which personal identities intersect with power, privilege, and/or oppression
- Evaluate personal positionality within a multicultural society and within the education system
- Create a personalized plan for ongoing reflective practice as an educator in the classroom.

Shared Agreements

We share a *collective goal* of becoming critically conscious educators who are prepared to serve all students in our classrooms. Grading Scale

Course Assignments and Grading

Autobiographical Reflection Paper (50% of Final Grade)

Candidates draw from the literature on critical race theory in education, intersectionality, lifespan theory, and/or other theories of human development to analyze their own positionality and sense of self living in a multicultural society. Candidates examine the ways that their own intersectional identities interact with power, privilege, and oppression, and how these worldviews and "ways of being" may impact their presence and interactions with students and families in the K-12 education system.

Participation, Engagement and Essential Dispositions (50% of Final Grade)

Candidates engage regularly and actively in class discussions, activities, and affinity groups as a means of building self-awareness and increasing their capacity and stamina for engaging in self-reflection around issues of identity. Candidates work to meet essential dispositions criteria in their coursework whether online or in person.

Course Policies

Participation

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
