COURSE DESCRIPTION

What is the relationship of human experience to the natural world? Why should we care about the environment? Ecological psychology attempts to answer these questions. Students will explore the relationship of humans to nature in multiple cultural settings and historical contexts. This course also discusses the impact of human culture on the natural world, and the ways in which individuals and societies can harm or help the environment.

COURSE OUTCOMES

In this course, learners:

- Articulate basic concepts of ecology and systems thinking as relevant to ecopsychology
- Discuss how the natural world is an integral aspect of human child development and adult mental health
- Compare, contrast, and connect the perspectives of a variety of schools of psychological thought toward the environment and how ecopsychology may be applied in a therapeutic setting
- Evaluate psychological strategies to create environmentally responsible behavior and help to alleviate current social and environmental problems
- Discuss the role that religions and spiritual beliefs play in a healing process that involves humans and nature
- Articulate essential features of the field of ecological psychology, or ecopsychology and its application in ecotherapy
- Discuss the role of the Western cultural, intellectual tradition and historical antecedents in creating a dualistic world view that contributes to consumerism, addiction, and psychological and environmental disease

Course activities

Class participation through discussion is an integral part of this online course, although it is typically less formal than other work submitted throughout the course. Participation is defined as active engagement in a discussion or other online activity. To provide a structure for balanced participation and allow you to maximize the benefit of the discussion boards, it is recommended that you follow these guidelines: 1) Post your responses to discussion questions in the first three days of the school week (Monday through Wednesday). 2) Post three or more thoughtful and topic-relevant comments to responses made by classmates during the last four days of the school week (Thursday through Sunday). 3) Respond to any questions that your instructor or peers have regarding your original post by the end of the school week.

Reflection papers (two equally weighted)

Paper 1 - This paper should a four- to five-page, formal written reflection on the course readings. As an introduction do an inventory of the themes you see so far in the course materials and discussions, then choose one or two of them and discuss your thoughts, feelings, and ideas about them in depth. You can also make comparisons with texts from other courses. Keep in mind that this is not just a summary paper, but an opportunity for you to voice your feelings and opinions about the reading material. Be sure to reflect on the origin of and reasons for your opinions. Use APA citations for sources you mention and include an APA format reference list.

Paper 2 - Imagine that you have been asked to present a brief paper introducing the concepts of ecopsychology and ecotherapy at a conference for beginning psychology students. Since the paper will be published in the conference proceedings, it must be a professional paper in APA format. You may focus on a particular issue or psychological approach that you see as relevant or interesting. Include a statement of how you plan to use ecotherapy in your practice and why, or if you do not, then why not. If you are not planning to practice psychology, discuss how the ideas of ecopsychology and ecotherapy can be used to support your personal growth and mental health. You can think of the paper has having two sections: an introduction to ecopsychology and ecotherapy with explanatory examples, and a statement of your position in regard to using these concepts in therapeutic practice. Check with the instructor to confirm you are on the right track. Use examples from the texts, your life and other reading, and include three sources in addition to the texts. The paper must be between four and five pages in length to fill your allotted speaking time. Submit this paper via the assignment link and post it to the discussion forum. The class will serve as your audience and will respond and ask questions in the following week's discussion forum.

Book review

Students are expected to complete a five- to seven-page book review that will allow them to go into more depth about an author or topic related to the course. Students may select a book from the bibliography of either text and confirm with the instructor that their selection is appropriate.

Course Journal

Students are expected to complete a weekly journal that reflects on ecopsychology, ecotherapy, the personal impact of the environmental crises in their life, their career plans, and how course ideas do or do not fit with their mission and vision. Students' reflections might take them into the past or the future. They could document students' understanding of the six approaches to psychology and ecotherapy and if and how they plan to integrate them into their practice of psychology or life practice for personal growth.
