## EML 485: Mathematics: Probability and Statistics

### **Course Description**

Candidates develop conceptual understanding of and procedural fluency with statistics and probability. Candidates learn to incorporate the standards of math practice within statistics and probability. Topics include summarizing, representing, and interpreting categorical and quantitative data; measures of central tendency, distributions, evaluation of random processes, populations and random sampling, randomization; single variable, multivariate, categorical, and continuous data; binomial probability distributions; the principles of probability; probability of compound events using technology to collect, represent, and analyze data; and using rules of probability to model, make predictions, evaluate decisions, and solve real world problems. Upon successful completion of this course, candidates have the knowledge and skills to help K-12 students become college and career ready in probability and statistics.

- Develop conceptual understanding of and procedural facility with probability and statistics.
- Apply standards of mathematical practice in probability and statistics.
- Anticipate and plan for student misconceptions and common errors

### **Course Assignments and Grading**

#### **Content Proficiency (40% of Final Grade)**

Candidates demonstrate conceptual understanding of and procedural fluency with math topics in the scope of this course. Instructors choose or approve the format in which candidates will show proficiency (e.g., exam, series of exams, discussion boards, group work, interviews, etc.). Students must achieve At Standard rubric scores for this assignment.

# Plan for Addressing Common Misconceptions and Errors (40% of Final Grade)

Candidates develop a plan for addressing common misconceptions and errors students are likely to show with respect to a Common Core State Standard in math about probability and statistics. The plan should include: 1) a description of common errors, 2) explanation for how the candidate will assess if and to what extent students show the common misconceptions/errors, 3) appropriate problems or scenarios that will allow the candidate to assess if and to what extent students show the common misconceptions/errors, 4) strategies to anticipate, pre-correct, and correct errors, and 5) connections to standards for math practice.

## Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

### **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
