Course Description

The focus of this course is to prepare candidates to differentiate process, content, and product to facilitate learning for students with diverse learning needs. Emphasis is placed on leveraging the strength, interests, and funds of knowledge of students. Candidates research and analyze key principles of differentiated instruction, how best to implement them into classroom instruction and evaluate the effectiveness of selected practices.

- Analyze the effectiveness of differentiated instruction in facilitating learning for diverse student needs.

- Implement differentiated instruction in an educational setting.

Course Assignments and Grading

Differentiated Instruction Paper (40% of grade)

Candidates describe and analyze the major components and features of differentiated instruction. Candidates should include an explanation of how to differentiate both instruction and assessment, how to use assessment to iteratively determine strengths, needs, interests, and funds of knowledge of students to further tailor and differentiate the instruction. An analysis should be included of research-based benefits and considerations for differentiating instruction.

Differentiated Instruction Plan (40% of grade)

Candidates will apply knowledge of differentiation to create and evaluate a plan to facilitate learning and/or engagement for student(s) who would benefit from differentiated instruction. Candidates should include a description of the student(s), including strengths, interests, needs, and funds of knowledge; including how these were determined. The plan should include an explanation of how to differentiate both instruction and assessment, how to use assessment to iteratively determine strengths, needs, interests, and funds of knowledge for student(s) to further tailor and differentiate the instruction. An analysis should be included of research-based benefits and considerations for the plan for the student(s).

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
