Course Description

In this course candidates will research the factors that influence English Language Learners (ELLs) second language development and investigate what instructional practices, strategies, materials, and accommodations are best suited for instruction in specific content areas (language arts, math, science, etc.) with those factors in mind. Candidates will examine culturally responsive teaching practices to support second language development and methods for integrating content, background knowledge, and vocabulary.

- Research individual and socio-cultural factors that may influence second language development
- Research and apply culturally responsive teaching practices
- Utilize effective communication strategies with ELL students and families

- Integrate ELL instructional strategies in content areas, i.e., social studies, science, mathematics

Course Assignments and Grading

Parent and Community Communication Plan (30% of Final Grade)

Candidates research ELL parent involvement, write a summary of the findings, and design a plan for increasing parent involvement. Candidates research a minimum of four articles that

address ELL parent involvement in schools and summarize their findings and then create a culturally responsive communication plan which includes the specific elements below:

- Summary of different cultures' parental roles in children's education
- Two barriers to ELL parent involvement in schools
- Two suggestions for improving parent involvement
- Two strategies to communicate effectively with parents of ELL children
- Two strategies for working with parents
- Four resources in the bibliography
- Peer review of communication plan by a minimum of one classmate is required with peer's suggestions and comments included.

Strategies for Mainstream and Sheltered Classes for Listening and Speaking (30% of Final Grade)

Candidates plan and teach a set of three consecutive listening and speaking skills lessons to ELL students in a sheltered English program or in a mainstream classroom. Candidates use the English Language Development (ELD) standards for the State of Washington to determine instructional expectations for the students, and record the experiences in a Reflection Log.

The log includes:

- Description of target students
- Learning targets
- Instructional plans with clear description of how plan models methods, techniques, and strategies found in research
- Explanation of how the lessons construct a learning environment that supports both English language and literacy development and content area achievement
- Explanation of how the lessons, and the methods on which they are based, accommodate cultural differences and develop cultural awareness in the classroom
- Discussion of how the use of the strategies helped develop the students' BICS and CALPs with specific examples of student responses
- Samples of all teaching materials
- Student voice evidence of learning targets achievement
- Description of the "next steps" based on student performance and the ELD standards at the conclusion of the three consecutive lessons
- Reflection on each the lessons

ELL Lesson Plan Set and Reflection in Content Area (20% of Final Grade)

Candidates plan, teach, and assess three or more consecutive ELL lessons in a content area, such as mathematics, social studies, or science and write a reflection about the experience. The lesson plans must utilize the TCP lesson plan template and include learning targets aligned to CCSS and ELD standards, and include at least one rubric for assessment or student self-assessment. The reflection must include a description of the background and cultural heritage of the students, including any cultural factors influencing success of their learning, explanation of how the lessons included each students' cultural identity and accommodated cultural differences, how the lessons were modified to meet the needs of diverse ELL learners, and how the strategies used increased the students' learning of BICS and CALPs with a minimum of three scholarly resources.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
