COURSE DESCRIPTION

In a global digital economy, customer-centric strategies drive business innovations. The web allows businesses to tap into a wealth of customer behavior in order to analyze and answer key questions such as “Which category of our customers continue to buy our products and why?” and “Who in our customers’ network is likely to adopt our product?” This course assumes that the tools to data mining and business analytics must be accessible to people within business domains. The course is self-contained and demands no background in programming. It is designed to take students over a series of introductory materials with an emphasis on the practical aspects of applying this knowledge to real-world business analytics problems. After taking this course, students can apply the tools provided to deliver business analytics solutions for data-driven decision making in a variety of business scenarios, such as pricing, marketing, and advertisement.

Weekly Exercises

Students will complete weekly exercises that allow them to learn and practice advanced business analysis. These weekly projects will represent opportunities to demonstrate competence in regression, classification, clustering, and optimization. Each of these projects will be completed using the R scripting language to expand students' data analysis tools.
