Course Description

The purpose of this course is to provide candidates with the pedagogical foundations, strategies, and understanding to modify curriculum and make accommodations to the learning environment. This course emphasizes the identification of students' needs, developing appropriate strategies, and collaboration between appropriate staff members. Upon successful completion of this course, candidates will be able to modify curriculum and make accommodations for students with special needs.

Course Assignments and Grading

Lesson Plan Revision (40% of Final Grade)

Candidates prepare or revise one lesson plan that reflects modifications or adaptations to meet the needs of all learners in the classroom. Modification or adaptations should be made for the

following: learning targets, assessment strategies (including self-assessment), best practices in lesson sequence, grouping, applicable technologies, and/or family interactions.

Special Needs Resource Guide (40% of Final Grade)

Candidates create a grid that describes appropriate resources (accommodations and modifications) for students with the following disabilities: autism, deafness, developmental delay (all 5 areas), emotional/behavioral disability, hearing impairment, intellectual disability, orthopedic impairment, ADHD, specific learning disability, speech or language impairment, traumatic brain injury, and visual impairment (including blindness). The grid should represent individual candidate schema, or organizational pattern. It should be comprehensive, as well as functional for use in future courses and internships.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
