Course Description

The Culminating Seminar features the candidate's presentation of a completed superintendent certification portfolio to a panel of experienced school district executives, administrators, and superintendents. Candidates demonstrate and explain how they have developed capacity for greater leadership while meeting the career benchmarks for each standard. The assessments for this course correlate the candidate's experiences, knowledge, skills, performances, and dispositions to national, regional, and local standards for superintendent certification.

Capstone Portfolio Presentation (80% of Final Grade)

The candidate makes a professional presentation on his/her electronic portfolio to a panel of executive administrators as a synthesis of having met standards for superintendent certification. The candidate entertains questions and comments from the panel. Although not a formal defense of the portfolio, the candidate must answer questions to the satisfaction of the panel. The instructor provides a rubric and details of presentation.

Presentation of Professional Growth Plan Executive Summary (20% of Final Grade)

The instructor will provide directions for the presentation of the executive summary.

The executive summary addresses the following key questions:

- What evidence describes your current knowledge, skills, dispositions, strengths, and growth areas?
- Based on this evidence, what are your strengths and areas for continued growth during Internships I, II, III?
- What are your professional goals for the next one to three months (Internship I)?
