COURSE DESCRIPTION

This course explores risks and opportunities for leaders to consider in the planning and management of organizational transitions. Emphasis is placed on analysis of uncertainty, internal and external politics, organizational culture adjustments, and communication of changes. Students will develop a comprehensive transition plan.

The instructor will provide grading rubrics that will provide more detail as to how this assignment will be graded.

Successful Organizational Change Factor Analysis

Identify and analyze the elements of successful organizational change and the forces that work for and against a successful organizational change. This paper should have four sections: (a) an introduction to the organization including its mission, vision, stakeholders and any other demographic or relevant data; (b) an analysis of the forces that work for the success of an organizational change; (c) an analysis of the forces that work against a successful organizational change; and (d) a conclusion. The paper should be 5-7 pages (1750-2450 words), double-spaced, 12 pt. Times New Roman font. APA writing conventions must be followed and a minimum of five (5) peer-reviewed, scholarly resources (in addition to the text) must be included.

Literature Synthesis and Organizational Change Plan

Students will synthesize ideas from the change literature to create a plan for a proposed organizational transformation. The plan will be to improve a process, product, or service in an organization they are familiar with. The Literature Synthesis and Organizational Change Plan will include: (a) an introduction; (b) a discussion of the organization, the transformation that is needed, and why it is needed; (c) a detailed plan for implementing the stated changes in the organization that is supported by a synthesis of academic sources on the topic and; (d) a discussion of how change success will be determined; and (e) a conclusion.

The organizational assessment and change plan will be provided in a 7-9 page paper (2450-3150 words), double-spaced, 12 pt. Times New Roman font. APA writing conventions should be followed and a minimum of five (5) peer-reviewed, scholarly resources will be included.

Organizational Change Evaluation

Students will evaluate the actions and results of an organizational or workplace change that they experienced. The organization or workplace selected will not be the same from previous assignments. The paper will include: (a) an introduction; (b) a brief description of the organization or workplace situation, the challenge that was being experienced, and the change that was enacted to address the challenge; (c) an evaluation of the change based on specific elements (see rubric); (d) an evaluation of the success or failure of change efforts; and (e) a conclusion. The evaluation is to be 7-9 pages (2450 - 3150 words) double-spaced, 12 pt. Times New Roman font. APA writing conventions must be followed and a minimum of five (5) peer-reviewed, scholarly resources (in addition to the text) must be included.

Formative Assessments

Class participation through formative assessments is an integral part of this course. Formative assessments can be journals, papers, activities, quizzes, discussions, wikis, or other activities determined by the course manager and instructor. Each formative assessment includes its own rubric and/or due date as outlined within the activity to balance participation and enhance learning. Whether in class, online, or in a mixed mode setting, students will be graded on their ability to present, explain, or defend alternative viewpoints and the degree to which they have mastered the concepts and principles inherent in the study of leadership. Written work is assessed on relevance to the subject presented, adherence to writing mechanics and organization, and professional presentation.

COURSE POLICIES

Late Assignments

Students are required to submit all assignments by the due dates stated in the course schedule. A late assignment is one that is submitted after the due date or after any extension has expired.

If circumstances prevent a student from meeting the due date, the student needs to contact the instructor and request an extension at least 48 hours prior to the date the assignment is due. Emergency situations will be considered on a case-by-case basis.

Being busy, pressured with outside work, technical issues, or having competing academic commitments are not valid reasons to grant extensions. A student who receives an extension in advance of the due date and abides by the agreement with the instructor is not subject to late penalties.

Without prior arrangement with the instructor, students who submit assignments late will receive a 5% deduction in grade each day or part of the day that the assignment is late up to a maximum of 25% off. Coursework received after 10 days will not be graded and will receive a zero grade, unless prior arrangements have been made.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.

Participation

Participation is determined through your active engagement in classroom activities each week. This can be measured through your discussion board posts or by submitting an assignment when due.
