Course Description

Candidates acquire functional understandings of the Common Core State Standards in Mathematics for content and pedagogy. Students focus on standards of mathematics practice, key shifts in mathematics, how students learn and do not learn math, collaborative teams, culturally responsive teaching, and Smarter Balance assessment. Students apply these learnings to specific math topics in the following content and pedagogy courses for the ultimate purpose of helping K-12 students become college and workplace ready in mathematics.

Course Outcomes

This course will prepare students to:

- Demonstrate understanding of how to embed mathematical practices in the instructional process to deepen conceptual understanding.
- Demonstrate a deepening understanding of how students learn mathematics and of the pedagogical knowledge specific to mathematics and teaching.

Grading Scale

Course Assignments and Grading

Math Lesson Plan Integrating the Mathematical Practices (50% of Final Grade)

Candidates will create a lesson plan, using the City U lesson plan template, that integrates a Common Core State Standard for math content with at least two Common Core State Standards for mathematical practice. Candidates should demonstrate the ability to integrate and scaffold mathematical practices in developmentally appropriate ways.

Mathematical Practice Matrix (30% of Final Grade)

Candidates create a matrix for the eight mathematical practices as they would be represented in a grade level of their choice. The matrix should include explicit examples of how each practice might appear in the classroom, content standards that have obvious connections to each practice

that you could leverage, strategies for guiding students to use the mathematical practice to make sense of math content, and possible challenges to watch for.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
