## Course Description

Candidates seeking certification co-teach with a cooperating teacher in a school placement in their content area(s) for a full school year from October through June to develop and demonstrate capacities to perform the full-time responsibilities of a teacher and to make a positive impact on student learning. During Apprenticeship/Residency II (January through March), candidates work with a field supervisor to develop their skill in planning, engagement, assessment, classroom culture, and essential dispositions. Required time for student teaching typically begins during Apprenticeship/Residency II. Candidates reflect upon their areas of strength and growth to set goals for the remainder of the apprenticeship.

- Refine practice through description, analysis, and reflection
- Apply education theories to the needs of students in the classroom context
- Collaborate with program peers in a professional learning community

## Course Assignments and Grading

### **Reflective Teaching Assignments (60% of Final Grade)**

Candidates will engage in reflective analysis about planning, instruction, assessment, and class culture. Candidates will analyze lesson plans, videos, or student work samples from either their own teaching experiences, or those provided by the instructor or mentor teacher. The focus of these reflections will be to enhance candidate's ability to analyze and improve teaching practices.

### **Hours Log (20% of Final Grade)**

Candidates will complete an hours log representing the time spent in their field experience placement. Candidates should complete separate hours logs for each endorsement area.

### **Participation, Engagement, and Essential Dispositions (20% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

## **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
