Course Description

This course addresses inclusion and specialist paradigms in special education including definitions of disabilities and program delivery. This course emphasizes identification, specific needs of students, service delivery, and legal issues. Practical application of these principles will form the foundation for future special education courses.

Course Outcomes

This course will prepare students to:

- Describe responsibilities of teachers of students with disabilities.
- Describe characteristics of disabilities
- Analyze the process by which students are identified for qualification for special education services
- Analyze implications and indications for classroom support for students with disabilities
- Explain federal and state legislation and rights for individuals with disabilities

Course Assignments and Grading

Knowledge of Foundations of Special Education (30% of Final Grade)

Candidates demonstrate understanding of the issues and responsibilities of a teacher for students with identified disabilities under the federal and state standards. Candidate includes a description of the rights and responsibilities of families in the process.

Characteristics of Disability Categories (25% of Final Grade)

Candidates demonstrate understanding of the disabilities identified in WAC and IDEA (Individuals with Disabilities Act) for qualification for services in special education, the characteristics of each disability and impact on student, family and community.

Characteristics of Learners (25% of Final Grade)

Candidates articulate the typical and atypical growth and development of children with disabilities and the impact of a disability on individuals, families and society.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
