## Course Description

This course provides teacher candidates with necessary foundations, strategies, and understanding to successfully perform assessments and evaluations. Topics include referral process, informal and formal assessments, test administration, data interpretation and implementation of data into the Individualized Education Program/Plan (IEP). Candidates demonstrate selection of appropriate assessment tools and then accurately interpret data to develop and implement an IEP for children who qualify for special education services. Course includes components of state requirements for certification.

## Course Outcomes

This course prepares candidates to:

- Analyze instruments/tests needed for assessment of a student with a suspected disability

- Interpret assessment data from curriculum-based assessments
- Demonstrate legal and ethical assessment practices and procedures
- Create and implement appropriate assessments for students in special education

## Grading Scale

The grades earned for the course will be calculated using City University of Seattle's decimal grading system, found in the current University Catalog (<https://www.cityu.edu/catalog/>).

## Course Assignments and Grading

### **Norm-Referenced Testing Process Analysis (20% of Final Grade)**

Candidates will write a research paper on two norm-referenced assessments used by school psychologists for special education referral and eligibility determination. Candidates analyze two different types of assessments – one academic/cognitive and the other in a different category

(social skills, adaptive behavior, gross/fine motor functioning, etc.). Candidates conduct an interview with a school psychologist about the process of test administration, interpretation, and collaboration with a multi-disciplinary team when reporting the results and monitoring student progress.

### **Curriculum-Based Assessment Analysis (30% of Final Grade)**

Candidates choose a focus disability category and research three different curriculum-based assessments that might be used for a student in that category.

For each assessment, candidates will include:

- Summarize of the purpose of the assessment,
- Identify the evidence base supporting the use of the assessment tool
- Appropriate age and/or ability range
- The appropriateness of the assessments for a given disability (of the candidate's choosing),
- Analysis of strengths and weaknesses of the assessment
- Identify and justify appropriate accommodations and modifications that would need to be made for the assessment to be accessible to a student in the chosen disability category.

### **Curriculum Based Assessment Creation, Implementation, and Reflection (30% of Final Grade)**

Candidates create an original curriculum-based assessment that is geared toward assessing a particular skill for one special education student. The assessment should be based on one of the student's IEP goals. Candidates will then give the assessment to the student, critically analyze/reflect on the results, and develop a future plan for increasing the student's performance on the skill that was assessed.

### **Participation/Engagement/Essential Dispositions (20% of Final Grade)**

Candidates engage regularly and actively in class discussions, activities, and affinity groups as a means of building self-awareness and increasing their capacity and stamina for engaging in self-reflection around issues of identity. Candidates will work to meet essential dispositions criteria in their coursework whether online or in person.

## **Course Policies**

### **Participation**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode

courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
