## Course Description

The purpose of this course is to understand the many complex cognitive processes and factors that contribute to skilled reading. Candidates examine the decoding portion of Scarborough's Reading Rope (2001) and how these strands lead to fluent, grade level reading as well as develop instructional activities that support the development of reading fluency (rate, expression, and prosody). In addition, candidates will also develop an understanding of the Science of Reading and how the evidence-based research should inform instruction while designing a structured literacy lesson plan and aligned unit plan. Finally, candidates investigate systematic, explicit instruction on the process of writing; sentence and paragraph construction skills, spelling skills, grammar within the context of writing, and text structures for writing. This course includes components of state requirements for certification.

- Develop instructional activities that address the three components of fluency (accuracy, rate, prosody)
- Understand the major skill domains that contribute to written expression (KPS 4G.1)

- Know/apply in practice considerations for research-based principles for teaching letter formation, both manuscript and cursive. (KPS 4G.2)
- Know/apply in practice considerations for research-based principles for teaching written spelling and punctuation. (KPS 4G.3)
- Know/apply in practice considerations for the developmental phases of the writing process. (KPS 4G.4)
- Know/apply in practice considerations for the appropriate uses of assistive technology in written expression. (KPS 4G.5)

#### **Structured Literacy Unit Plan (30% of Final Grade)**

Candidates design an integrated Language Arts unit of no less than five days following the program-approved unit plan format designed to improve achievement in one of the following components of reading: phonological or phonemic awareness, phonics, fluency, vocabulary, and comprehension. The unit plan may also integrate content from one other subject matter discipline. The unit plan describes learning targets for subject matter, explicit literacy instruction, acquisition of academic language, accommodations for all learners (IEP, ELL, language acquisition, family engagement), and opportunities for students to use technology. Instructors may ask team members to share their plans as appropriate with their peers.

#### **Fluency: Research and Application (20% of Final Grade)**

In this assignment, candidates examine reading fluency. In a 3-5 page research essay, candidates define the three components of fluency (accuracy, rate, prosody) and discuss the importance of fluency assessment and progress monitoring in order to inform instruction and intervention. Candidates also analyze how the decoding portion of Scarborough's Reading Rope (particularly decoding and sight word recognition) influences fluent, grade level reading, as well as the variables that affect overall fluency, and therefore comprehension. Candidates also develop three instructional activities, one for each component of fluency. *An instructional activity template will be provided for this assignment.*

### **Three Sequenced Writing Lessons (30% of Final Grade)**

Candidates develop three sequenced instructional plans on the writing traits or writing process using the TCP Lesson Plan template. Candidates choose a children's literature book to model to demonstrate the integration of the reading and writing process.

Include:

- TCP Lesson Plan Template for all three lessons
- Title of the literature selection(s) and rationale for the selection(s)
- The writing lessons identify one or more writing traits (ideas, organization, sentence fluency, word choice, voice, and conventions) and/or writing process
- Alignment between the central focus (big idea/essential question), state standards, learning targets, learning tasks, resources and assessments
- Student voice evidence in which the students express their progression of learning.
  
- A rubric to support students in evaluating their own progress in at least one of the lessons.

### **Participation, Engagement, and Essential Dispositions (20% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

## **Course Policies**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
