COURSE DESCRIPTION

Students will become familiar with the CityU Doctoral Program, online success tips, and academic writing resources. Tutorials and short quizzes or exercises in scholastic honesty, writing conventions, and APA citations will help prepare students for doctoral-level work. This is a self-paced class.

SPECIFICS OF COURSE ASSIGNMENTS

Course syllabi will include grading rubrics that will provide more detail as to how assignments will be graded. The three required assignments are listed below. **Note: In LDRD 600, no rubrics are used for the assignments but you should expect to see rubrics on all assignments used in the doctoral program.**

Quizzes

Students will complete quizzes spanning policies, scholastic honesty, and APA style. Answers are either correct or incorrect.

Exercises

Students will complete writing and APA exercises.

Blackboard Activities

Students will post on the Discussion Board and upload documents.

COURSE POLICIES

Late Assignments

Doctoral students are required to submit all assignments by the due dates stated in the course schedule. A late assignment is one that is submitted after the due date or after any extension has expired.

If circumstances prevent a student from meeting the due date, the student needs to contact the instructor and request an extension at least 48 hours prior to the date the assignment is due.

Emergency situations will be considered on a case-by-case basis.

Being busy, pressured with outside work, technical issues, or having competing academic commitments are not valid reasons to grant extensions. A student who receives an extension in advance of the due date and abides by the agreement with the instructor is not subject to late penalties.

Without prior arrangement with the instructor, students who submit assignments late will receive a 5% deduction in grade each day or part of the day that the assignment is late up to a maximum of 25% off. Coursework received after 10 days will not be graded and will receive a zero grade, unless prior arrangements have been made.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.

Participation

Participation is determined through your active engagement in classroom activities each week. This can be measured through your discussion board posts or by submitting an assignment when due.
