Course Description

In this course candidates articulate and evaluate the instruction/assessment/evaluation cycle and its effectiveness on teaching and learning. After researching current practices, candidates modify instruction, implement assessments, analyze assessment results, and plan further instruction based on data as well as provide actionable feedback of instructional progress towards learning goals.

Course Assignments and Grading

Process IEP/Placement Meeting and Written Description (80% of Final Grade)

Articulate the continuous cycle of assessment, evaluation, and instruction in a research essay, with 5 or more scholarly resources.

Essay includes:

- Identify a variety of formal and informal assessments as leading indicators of student progress in language and literacy development.
- Modify instructional and assessment strategies to meet individual differences among all learners, as related to current standards for literacy learning.
- Develop independent learners who are able to self-assess and set goals.
- Integrate technology and current research-based practices to strengthen the assessment cycle.
- Provide ongoing, actionable feedback of assessment/instructional progress and/or learning needs:
 - Students
 - Families
 - Colleagues/ School Learning Teams
 - District/community

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
