Course Description

In this course candidates examine how teachers use professional databases and emerging technologies to search for scholarly sources, promising practices, and innovations that inform and improve classroom practice and student learning. Candidates learn methods of organizing and filtering literature to deepen a personalized study. Professional writing skills of objective analysis are exercised to synthesize, substantiate, validate, and communicate with credibility. This course prepares candidates to conduct a review of the literature in their own area of inquiry.

This is the second in a 4-course sequence that will guide candidates through a masters capstone project. Over the course of this series, candidates examine how teachers embed inquiry and reflective practice into classroom learning and teaching. Topics in this course include professional writing expectations for a literature review, synthesizing across sources, substantiating, and validating. This course prepares candidates to propose a compelling study and conduct a full literature review.

Course Outcomes

This course prepares students to:

- Identify one or more questions and multiple key words to inform an initial exploration and review of scholarly and emerging sources.
- Apply research skills of searching, organizing, and managing sources using professional databases, technological tools, and course resources.

- Demonstrate professional writing of objective analysis through an *initial* review of literature
- Demonstrate collegial dialogue and reflective practice through criterion-based self-assessment and peer-review.

Additional Information

Through graduate level inquiry, candidates add to the body of knowledge in the field. Candidates demonstrate professional dispositions in self-directed learning, collegial dialog, professional oral and written communications, and reflection on growth and change.

Grading Scale

Course Assignments

Key Word Worksheet

The candidate downloads and works through a set of activities developed by the City University librarians and College of Education faculty to practice the skills of moving from observation and questions to identifying key words to search the literature. Candidates view the library videos at each link, then submit a completed worksheet for both peer-review and instructor feedback

Initial Literature Review

The candidate writes and submits a brief (3-4 page) initial review of literature related to the topic and questions of their research interest. Applying a professional writing style of objective analysis, the candidate reviews and synthesizes multiple sources in order to establish a foundation for the study. Candidates use criteria of professional writing and criterion-based assessment for self- and peer-assessment in preparation to expand on their work in a full review of the literature in the coming quarter.

Discussion, Collaboration, and Essential Dispositions

Candidates participate and engage in all classwork, including required assignments, discussions, activities, and instructor-determined assignments. Candidates demonstrate essential dispositions criteria through collegial dialogue and peer-review in this course as well in the field.

By completing the discussion by the posted deadlines, candidates provide their perspective in collegial dialogue.

Course Policies

Instructor Determined Dialog and Participation

The instructor will determine the expectations for professional dialog or participation in activities that support the course outcomes and major assignments of the capstone. Descriptions are provided by the instructor in the course. Each student will have individualized attention and advising on their personal project and will be expected to communicate individually with the instructor regularly.

Timely completion of discussion boards, along with completion of the Ethics Modules, will determine your Pass/No Pass grade for the course.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.
